#### **Public Comments**

Russ Hartman, as a Penn St Watershed Specialist, commented on his interest in the Township's stormwater management plan and the Stormwater Advisory Council.

## **Committee Reports:**

# **Building and Subdivision Review**

Peter Tantala reviewed the 1) VW Piazza 1862 Lincoln Hwy plan submittal: very little environmental impact. Corner will be beautified. Steep slope concerns. Needs DEP approval. The same letter sent in August will be reissued. CAP needs to be adhered to, PINDI search is necessary, and steep slope concerns. The letter is due November 1. Sidewalks will be suggested according to the MMIP.

2) Chick-fil-A at Oxford Valley by Sesame Place. Existing CFA building will be demolished, new building will replace from ground up. New building will be relocated slightly to accommodate a wider, designed drive-thru. A stormwater management system will be put in place. No environmental concerns. EAC suggests that the CAP be



addressed with specific items highlighted. Lauren will email Peter with suggestions. Peter will send a letter by November 1, 2024.

# Stormwater Management Advisory Committee (SWAC):

Andy, Peter, and Joe are on the SWAC. The EAC needs to vote on a stormwater management fee. Grants are available. Russ suggested rebates for residents that install methods to reduce stormwater, for example, rain gardens. Kevin stressed being able to



measure success. Juliana was suggested as an intern to help with monitoring, possibly working with the township engineers.

Motion to approve a stormwater management fee passed 6-0; Lauren abstained.

Langhorne Spring Water Company- Andy suggested a visit since the last visit was January, 2020.

Holiday Open House- Joanne Morelli: each table should offer a holiday craft. EAC decided on the craft with pine cones.

Middletown Township received a million dollar grant from DCED/Local Share to replace metal halide lights with LED lights at Community Park. Paul hopes to install lights in 2025.

#### Old Business:

Speaker series review. Other EAC's are interested in starting a speaking series. Grace needs to contact Paul with information for the Winter Guide by November 1.

#### **New Business:**
