Note in EAC Minutes: On this night, about 140 residents of Middletown Township attended the Newtown Twp Board of Supervisors in opposition of the NBCJMA proposing a WWTP that will pour 2.5 million gallons of effluent into Lake Luxembourg daily. It can be viewed here.

January 8th Climate Action Plan (CAP) Meeting Minutes

During the EAC's CAP subcommittee on January 8th, the attendees reviewed the five-page draft that Kevin Deeny prepared. This white paper, once adopted by the entire EAC will be shared with the Middletown Twp Mgr, the Middletown Board of Supervisors, and the citizenry at large. Middletown is in strong opposition to WWTP and encourages Newtown to remain in the BCWSA system and the Neshaminy Interceptor, which is a large sewer pipe that carries wastewater from BC to the treatment facility in Philadelphia. BCWSA is upgrading the interceptor to handle increased flow.
