Township Manager's Report, New Pedestrian Safety Beacon Approval and Summer Rec Fundraising Success Shine at August Meeting



At the August 11th Board of Supervisors meeting, the Middletown Township Board of Supervisors:

- Heard a 30-day report from Township Manager Eden Ratliff, highlighting strategic planning, Township and Board priorities, and next steps. He will be presenting a 2026 Work Plan in the coming months.
- Approved the installation of a Rectangular Rapid Flashing Beacon pedestrian signal at the intersection of Langhorne-Yardley Road and Maple Point Drive to improve pedestrian safety.
- Celebrated our Summer Rec Kids, who raised \$2,175 for Fostering Hope Lower Bucks through their 4th Annual Charity Car Wash and various acts of kindness—benefiting local children in foster care.

The next Board of Supervisors meeting will be held on Monday, September 8, 2025, at 7:00 PM at the Middletown Township Municipal Center.

The workshop also included discussion of key budget terms and priorities, as well as time for public input.
