

Cars will be directed to the Shoppes at Flowers Mill shopping center and will receive candy from local businesses and first responders.



2020 Election Information

The 2020 General Election is coming soon - Tuesday, November 3!

Most voters who have requested a mail-in or absentee ballot already received them. If voting by mail, voters must carefully follow the



included instructions to enclose your ballot in the secrecy envelope, followed by the mailing envelope. Anyone voting by mail is strongly encouraged to complete and return their ballot as soon as possible.

Bucks County has made three ballot drop-off locations available for residents to utilize in addition to the mail. These locations are in Levittown, Doylestown, and Quakertown. Addresses and hours of operation are available on the <u>Bucks County voter website</u>.

In Bucks County, all registered voters are assigned to vote at a specific polling place based upon their address. To find this list, please <u>visit the Bucks County Board of Elections website</u>. Voters of the Upper 1 precinct have been moved to the Middletown Township Municipal Center.

October is National Fire Prevention Month



October Prevention is Fire Month! The goal of Fire Prevention Month is to raise fire safety awareness, and help ensure your home and family has a plan and is ready for the unexpected. We celebrate Fire Prevention Month by raising fire safetv awareness and educating families, students, and communities across the United States. During this month, fire departments provide

education to their communities, and encourage parents and loved ones to practice fire safety and whole home safety.

The National Fire Protection Association's (NFPA's) 2020 campaign for Fire Safety Month is "Serve Up Fire Safety in the Kitchen." We are proud to support their mission and this year's theme to <u>'Be Ready for the Unexpected'</u>, especially while cooking. We are urging families to <u>improve their home's safety.</u> Be ready at home by installing smoke and carbon monoxide alarms, as well as having fire extinguishers at home. 3 of every 5 home fire deaths occurred in homes without working smoke alarms.

How to Prevent Stormwater
Contamination When Fertilizing Your Yard

Water that runs off your property heads directly into the Township's stormwater system. This water can easily become contaminated by anything on the ground, especially yard fertilizer used on grass and plants. When fertilizer is not correctly applied or lands on an impervious surface, it can



dissolve into our stormwater system.

Fertilizers are used by homeowners to maintain and improve the quality and beauty of their landscapes. However, the ever-increasing use of home lawn and garden fertilizers has caused concern about the harmful effects these fertilizers have on groundwater and aquatic ecosystems.

Most commonly used fertilizers contain three basic plant nutrients: nitrogen, phosphorus, and potassium. Some fertilizers also contain certain micro-nutrients necessary for plant growth such as zinc and other metals. Increased amounts of nitrogen, phosphorous and these micro-nutrients have negative impacts on water quality and aquatic life. They can also cause health issues for humans and animals when they infiltrate our drinking water sources.

Using the correct amounts of fertilizer and taking the time to apply it carefully so it won't wash into storm drains from driveways and sidewalks can enhance plant growth without polluting the environment. When watering the lawn after fertilizing, don't allow the water to run into the street. Always clean up any spilled fertilizer and dispose of it properly.
