

2022 Preliminary Budget Presentation Set for November 15th

Middletown Township was recently awarded the Distinguished Budget Presentation Award by the Government Finance Officers

Association (GFOA) for its 2021 Budget for the third consecutive year. This award represents a significant achievement reflective of a commitment by the Township to meeting the highest principles of governmental budgeting. The 2022 budget is being prepared in accordance with GFOA's criteria.

The first budget workshop for the 2022 budget was held on Monday, October 18th. The second workshop will be held on Monday, October 25th, at 6PM. Following the budget meetings, we will be presenting the budget at the Board of Supervisors

meeting on November 15th for preliminary approval.

The 2022 budget will be submitted upon final approval by the Board of Supervisors in December.

Massage Parlor Ordinance

On October 4th, at the Board of Supervisors meeting, an ordinance was passed to limit massage parlors used for criminal activity and human trafficking.

Over the past few years, the Township has seen an increase in the number of illegal massage establishments. Some establishments make issues such as human trafficking, sexual exploitation, and others worse. Having this ordinance in place will help be more proactive in addressing what is becoming a significant quality of life issue in the Township.

Chief Joe Bartorilla said, "Enacting this ordinance is taking a proactive approach rather than a traditional reactive approach, as it is much easier to prevent an illegal establishment from opening than it is to close an existing one."

Several surrounding municipalities in the region have enacted similar legislation and it has been, overall, successful for them. This ordinance will make a positive impact on the quality of life within the Township.



Recycling Best Practices

Often times we think that we are doing the right thing when we are disposing of our recyclables, but there are a few key things to keep in mind.

Paper, cardboard, metal cans, plastic bottles and jugs are all recyclable as long as they are free of food and liquid. One dirty item can contaminate an entire truckload. Prior to disposing of your recyclables, all containers must be washed and have their labels removed.

Another tip before you dispose of your recyclables is to never put them in plastic bags or anything other than your regular recycling bin. Plastic bags and plastic wrap get jammed in recycling processing equipment.

When recycling make sure to keep these three rules in mind:

- 1. Recycle clean bottles, cans, paper and cardboard.
- 2. Keep food and liquid out of your recycling.
- 3. Avoid using bags to hold recyclables.
